- NSA added new deflection criteria specifically for sunroom products for the 2009 IRC and IBC.
- NSA completed a sunroom-specific code compliance checklist for the 2003 IRC and Energy Code. A 2006 IRC and Energy checklist is forthcoming.
- NSA is currently working on new standards and a fire code compliance project.
